Common Issues

Code Enforcement is no longer in Community Development. The division is now in the Police Department. <https://www.springville.org/police/services/code-enforcement/>

Can my HOA require me to do (fill in the blank).

HOA requirements are not governed by the city, they are a private agreement between property owners. Please read your HOA agreement.

My neighbor built a structure on the property line.

Property lines are not measured by the City. You must measure from the pin or hire a surveyor to get the exact locations. Property line disputes are a civil matter and you will have to work it out with your neighbor. Seek legal assistance if needed.

My neighbor built something that is questionable. What can I do about it?

Submit a code enforcement complaint. <https://www.springville.org/police/code-enforcement/>

My neighbor's leaves fall on my lawn. Who is responsible to pick them up?

Leaves that fall from a neighbor's tree onto your lawn are your responsibility to clean up.

My neighbor's fence is over the property line, tell them to move it.

This is a civil matter. You need to work it out among yourselves. Hire legal representation if needed.

My neighbors tree caused damage to my yard/ house/ fence, can you force them to pay damages?

This is a civil matter. Hire legal representation if needed.

How do I report a property with tall weeds?

You can submit for a code enforcement complaint. See link above.

Can you tell me if there are any permits for an address? What kind of permits do they have? How much did it cost? Who pulled the permit? Who is their contractor?

Please submit a GRAMA request on our website at <https://www.springville.org/grama-request/> We have 10 business days to do the research and we will let you know if we have the information or not. There are costs associated with GRAMA requests. Some information is proprietary and cannot be shared.

The Public Works Department will have to answer Public Works Questions. We can answer Planning, Building and Business Licensing Questions.

The city Engineer isn't answering my calls. Can you answer them for me? Can you get them to call me back?
