### Required Documents for Review Hearings

When you come in for your first review hearing, you must bring the **assessment** from the provider you had an assessment from. An **assessment** is a document prepared by your treatment provider that discusses their recommendations for your treatment. **NOTE: If you fail to bring your assessment on the date of your review hearing, you will violate the terms of your probation and will be sanctioned.**

### How to submit an assessment

There are three possible ways you can submit an assessment to the court:

1. Bringing a physical copy of the assessment to the court windows
2. Email a pdf copy of the assessment to [jcspringville@utcourts.gov](mailto:jcspringville@utcourts.gov), OR
3. The treatment provider submits the assessment directly to the court before the hearing date

The judge reviews the assessment **BEFORE** your hearing, so be sure to provide the assessment **AT LEAST** the day before.

**NOTE: If your treatment provider tells you they will submit the assessment directly to the court, you still have the responsibility to contact the court to be sure your assessment has been submitted before your hearing date.** You may contact the court and submit an assessment at any time during regular business hours, Monday through Friday 8:00am-5:00pm using the information below:
